
What is Parks On The Air (POTA)

- POTA is a non-profit 501(c)(3) organization that supports the use of amateur radio in US state and national parks as well as international parks. POTA has several goals:
 - Encourage people to discover and enjoy the great outdoors
 - Develop and practice emergency communication skills
 - Expose the public to Amateur Radio
 - Earn awards
 - ► Have Fun!!!









POTA History

Back in 2016, the ARRL sponsored a year long event called National Parks On The Air or 2016 NPOTA. The success of this event spawned the creation of the current Parks On The Air program by a handful of HAM's. Since then it has grown to include state, national parks, and trails in the US as well as parks in 50 other countries.

Who can participate?

- There are two types of POTA participants, Activators and Hunters.
- Activator A HAM or HAM group that has registered with the POTA website and sets up a station in a registered park with the purpose of making POTA contacts.

Hunter – Everyone else! The person trying to make contact with an Activator. You do not have to be registered with POTA to have a POTA QSO. Your contact will count for the activator and be logged with the POTA organization. However, you will not be able to participate in the awards program without being a POTA registrant.

How Do I Start?

Answer a POTA CQ call!

POTA web site lists activation schedules as well as current activation sightings known as spots.

If you want to earn awards or activate a park, you must register with the POTA website <u>www.parksontheair.com</u>

Basic Rules

- Beyond standard amateur radio on air protocol, the POTA Code of Conduct adds a few specific items. You will be removed from the program for any of these violations.
 - No Threatening or abusing members of the Admin team or any other POTA participant.
 - No discourteous, offensive, argumentative, copyright infringing, or advertising posts on the POTA site/forum.
 - No offensive or derogatory callsigns allowed to participate in POTA.
 - Do not attempt to hack the POTA website.
 - No behavior that discredits the integrity of the POTA program.
 - No operating outside of the ARRL operating ethics or the DX Code of Conduct

Hunter Rules

- Register on the POTA website
- Respond to a POTA activation
- POTA does not require a formal exchange but typically callsign, signal report and location are the minimum. A QSO may be quick or the activator may want to talk for a bit depending on if they have a pile up.
- Hunters do not submit logs to POTA (you can still log it as a personal QSO). The contact is credited to the hunter when the activator submits their log.
- If you have access to the POTA website, help the activator by spotting his station after a successful QSO.

Activator Rules

Register with the POTA website.

- Schedule your activation on the POTA website (suggested).
- The park must be open and you must be allowed to be there.
- All park rules must be followed. Discuss with park staff your intentions and any concerns you or they may have. If you have a question, ask. Some parks don't allow things like stringing ropes/wires from trees, etc.
- You can use commercial park power but all equipment used must be physically in the park barriers, except for trails (which must be within 100ft).
- There are no restrictions on bands or operating modes.
- You must make a min of 10 QSO's for the activation to count.
- > You can spot yourself on the POTA website.



- The activator must submit the logs in ADIF format via email to the POTA regional coordinator even if the activation was unsuccessful.
- Only submit one log per park. If activating a different park in the same day, you must submit a separate log. However, the same park activation over several days can be in the same log.
- It is recommended to use logging software but paper logs can be used, they will just have to be input into a logging program before submission.
- > When operating a special event or club, the club and the individual operator will get credit for the QSO's.
- Currently with COVID-19 issues, POTA is asking folks to wait for 1 month before asking about log status. But typical processing time is 1-2 wks.

What is ADIF?

- Amateur Data Interchange Format (www.adif.org)
- Open standard for exchange of data between ham radio software packages available from different vendors
- ADIF 1.0 was developed by Ray Ortgiesen IV (WF1B) and Dennis Hevener (WN4AZY) and introduced in 1996.
- Widely accepted by most Amateur radio software publishers
- Current version is 3.1.2

Awards! Awards! Awards!

- POTA has many <u>awards</u> for Activators and Hunters in 4 general categories: Standard, Advanced, Geographic, and Special. Below are just SOME of the awards available.
 - Standard Bronze, Silver, Gold, Platinum, Diamond, and Sapphire awards based on reference areas (unique parks) up to 75 total.
 - Advanced awards are for 100-7500 total reference areas (yes there really are that many registered parks! VE3LDT has hunted 7493 parks)
 - RaDAR (Rapid Deployment Amateur Radio) awards for multiple park activations in 24 hours. Awards based on distance and number of activations.
 - Worked All States, Worked All Parks in a state
 - Repeat Offender award for the same park
 - Park to Park awards (activator to activator QSO)
 - 6 Pack award (6 parks on 6 meters)

Summits On The Air (SOTA)

 SOTA is an award scheme for radio amateurs that encourages portable operation in mountainous areas.
